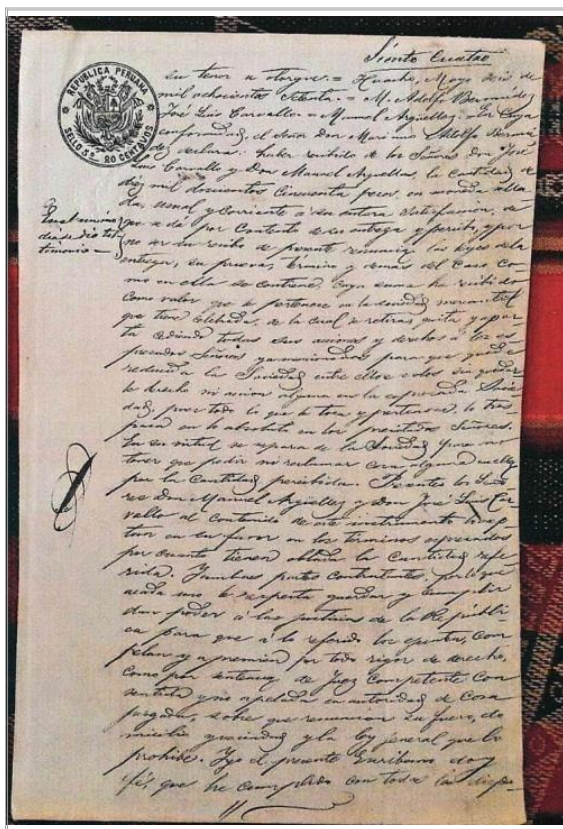


Image: Previous View

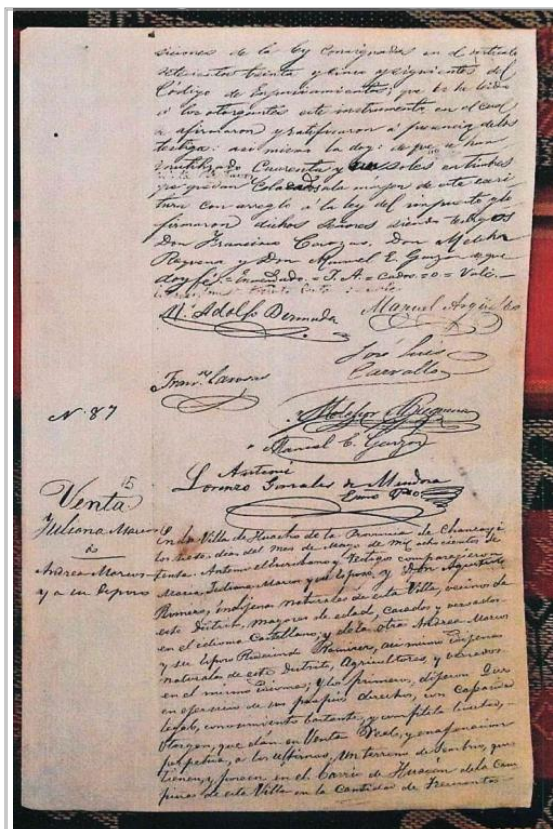


Image: Rear View

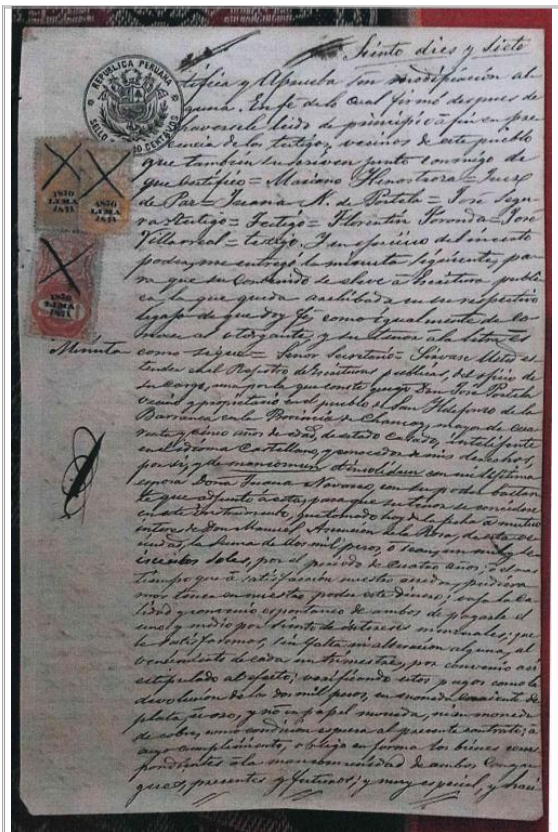


Image: Previous View

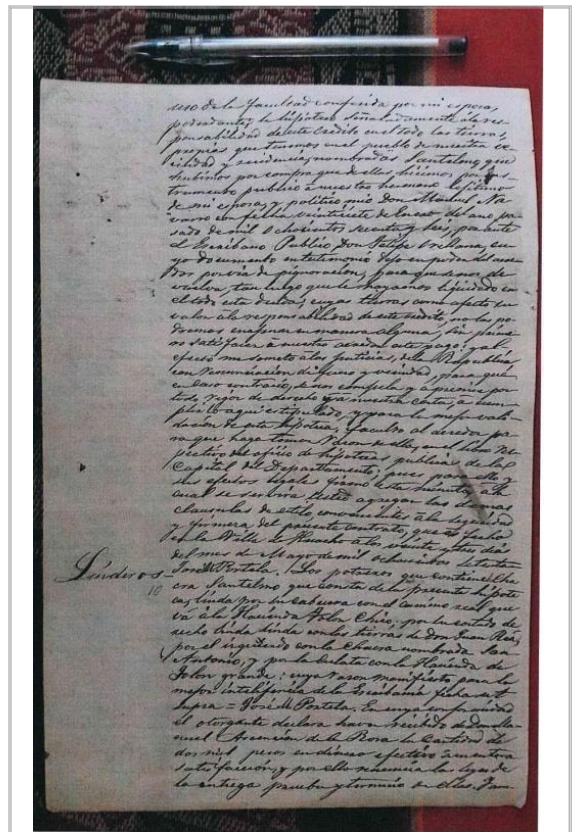


Image: Rear View

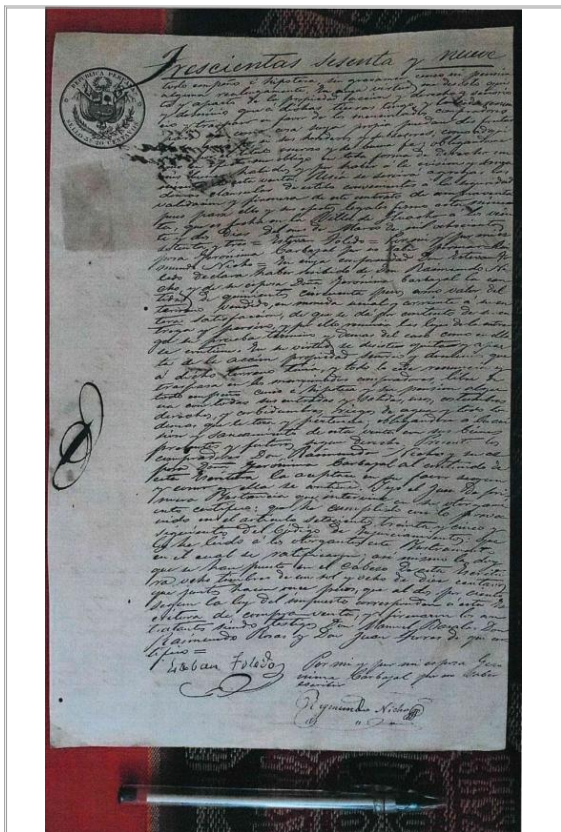


Image: Previous View

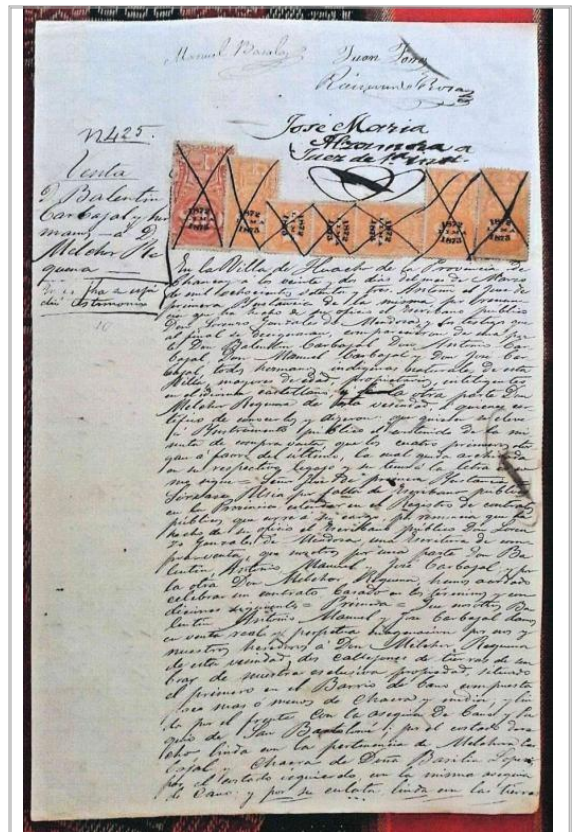


Image: Rear View

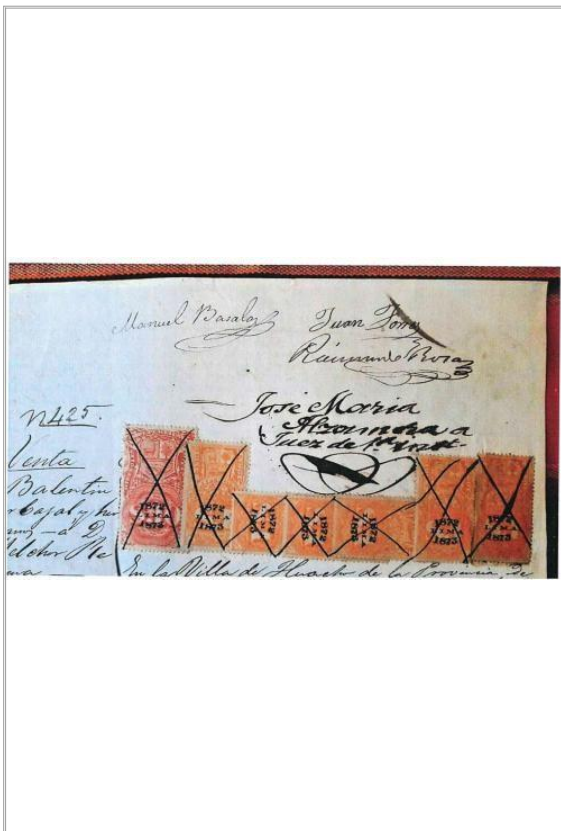


Image: Detail with stamps
